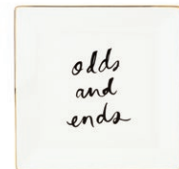

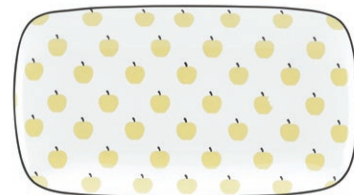

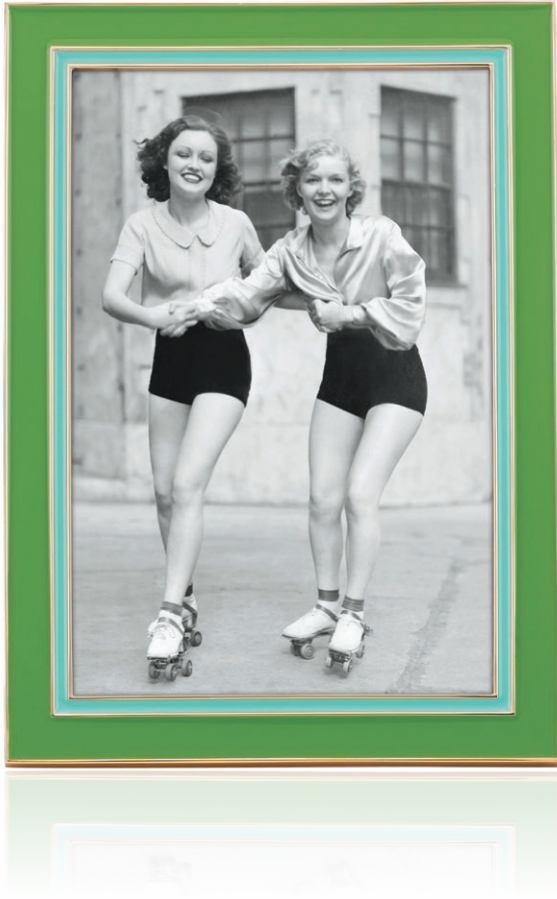

### *caring for china*

#### **USING**

#### **WASHING**

#### **STORING**

- WHEN STORING PLATES, TRY NOT TO SLIDE THEM OVER ONE ANOTHER AS THIS MAY CAUSE SCRATCHES ON THE GLAZE. **15. ATTORNMENT** TO GIVE EFFECT TO THE CUSTOMER'S OBLIGATION ARISING UNDER THESE TERMS, THE CUSTOMER IRREVOCABLY APPOINTS ANY SOLICITOR OF WWRD AS ITS ATTORNEY IN ALL THINGS.

**16. RETAIL PRICES** RETAIL PRICE BOOKS WILL BE AVAILABLE TO RESELLERS FROM WWRD, WHICH WILL LIST ALL CURRENT PRODUCTS AVAILABLE AND RECOMMENDED RETAIL PRICES.

**17. DEFAULT** A) UPON ANY DEFAULT OR BREACH BY THE CUSTOMER OF THESE TERMS OR OF ANY OTHER DEALING OR ARRANGEMENT WITH WWRD ("DEFAULT") WWRD MAY AT ITS DISCRETION, RETAIN

**19. DESCRIPTION** WWRD WILL HAVE FULFILLED ITS OBLIGATIONS UPON HAVING AVAILABLE FOR DELIVERY PRODUCTS (PLUS OR MINUS 5%) WHICH COMPLY WITH THE GENERIC DESCRIPTION OF WHAT WAS ORDERED.

**26. FORCE MAJEURE** WWRD WILL NOT BE IN DEFAULT OR IN BREACH OF ANY DEALING WITH THE CUSTOMER AS A RESULT OF FORCE MAJEURE. FORCE MAJEURE MEANS ANY THING OR EVENT BEYOND THE REASONABLE CONTROL OF WWRD AND INCLUDES ANY STRIKE OR LOCK-OUT.

**27. INSOLVENCY** A) IF THE CUSTOMER COMMITS OR IS INVOLVED IN ANY ACT OF INSOLVENCY, IT AGREES IT SHALL BE DEEMED IN DEFAULT UNDER THESE TERMS B) AN ACT OF INSOLVENCY IS DEEMED TO INCLUDE BANKRUPTCY, LIQUIDATION, RECEIVERSHIP, ADMINISTRATION OR THE LIKE.
